हार्बर मार्गावर २६ जानेवारी २०२६ रोजी वातानुकूलित लोकल सेवा सुरू करण्यात आल्या होत्या. सुरुवातीपासूनच या सेवांना प्रवाशांचा उत्साहवर्धक प्रतिसाद मिळत असल्याने मध्य रेल्वेने १ मे २०२६ पासून हार्बर मार्गावर आणखी १४ अतिरिक्त वातानुकूलित सेवा सुरू केल्या. या

- Cyber Fraud :** Subsequent to the quarter ended June 30, 2025, a cyber-fraud on the Company have been identified on July 2, 2025, involving Rs. 192 lakhs. A FIR was lodged with the cybercrime authorities on the same day. As of the date of approval of these financial results by the Board of Directors, Rs. 18 lakhs has been recovered.
- Demerger:** The Company has applied to the Metropolitan Stock Exchange of India Limited (MSE) on October 1, 2025, under Regulation 37 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, for the proposed Scheme of Demerger between Anglo-French Drugs and Industries Limited (the "Demerged Company") and AFD Enterprises Limited (the "Resulting Company") for the purpose of obtaining the No Objection Certificate (NOC). The Company has received the No Objection Certificate (NOC) from MSE on March 5, 2026, and the company is in the process of filing the requisite application with the National Company Law Tribunal (NCLT) for its approval of the Scheme. **Recent Regulatory Developments:** The Government of India has consolidated 29 existing labour legislations into a unified framework comprising four Labour Code viz Code on wages 2019, Code on Social Security 2020, Industrial Relation Code 2020, and Occupational Safety, Health and Working Condition Code 2020 (collectively referred to as the "New Labour Codes"). These Codes have been made effective from 21st November, 2025. The corresponding all supporting rules under these codes are yet to be notified.

East Bengal host Inter Kashi in Kolkata, while Mohun Bagan face SC Delhi in another crucial encounter. certainly secure the title for East Bengal, unless Mohun Bagan record a significantly bigger victory in their own game. For Mohun Bagan, the equation is simple: they must better East Bengal's result to become champions. If both Kolkata clubs finish level on points again, head-to-head results will be checked first, but as both derbies ended in draws, goal difference would decide the standings. Punjab FC and Mumbai City FC know that only a win will realistically keep them in contention. Victory would take either side to 25 points, but they would still need both East Bengal and Mohun Bagan to fail to win their matches. Jamshedpur's path is the most difficult. They must defeat Odisha FC and hope East Bengal and Mohun Bagan both

lose, while Punjab and Mumbai City draw. An extraordinary multi-team tie scenario is also possible. If East Bengal and Mohun Bagan both lose, Punjab and Mumbai fail to win, East Bengal would still emerge champions through the tie-break system.

Virat Kohli hails Indian hockey players' fitness, says that cricketers aren't even 15% as fit, sparking strong reactions from the hockey community. Ace India batter Virat Kohli has said that cricketers don't have even 15% of the fitness of hockey players, in a claim that has now gone viral on social media and has drawn heartfelt reactions from Indian hockey players. Kohli is considered one of the fittest cricketers of the modern generation and coming from him, the statement has expectedly garnered a lot of attention. Notably, while cricket has become a fitness-driven sport, with Kohli being one of the flagbearers of fitness



standards, hockey seemingly needs a lot more stamina. "I know people sometimes look at fitness as something extraordinary, but for me, it is what the job demands. ## 'Bibi's Hair Was On Fire': Inside The Dramatic Trump-Netanyahu Call That Exposed Rift Over Iran War

Washington DC

United States President Donald Trump and Israeli Prime Minister Benjamin Netanyahu reportedly again clashed over what should be the next steps in the ongoing war with Iran. The two leaders held an hour-long, tense call during which the Israeli prime minister called for resumption of airstrikes on Iran as Trump kept insisting that diplomacy should be given one more chance before the countries take up arms again. According to Axios, as Trump and Netanyahu spoke about new efforts to reach a deal with Iran in what was called a "difficult call" on Tuesday, some sources suggested that Netanyahu's "hair was on fire" after the call.



Trump said Netanyahu "will do whatever I want him to do" on Iran war, and added that they share a good relationship. Despite their temporary disagreements on Iran, the two leaders have remained closely coordinated throughout the war. "The only question is do we go and finish it up or are they going to sign a document. Let's see what happens," Trump said at the Coast Guard Academy. Later, the president said that the US and Iran were "right on the borderline" between finalising a deal and resuming the war.

Where US-Iran Negotiations Stand Today  
Earlier this week, Trump said he had put on hold plans for a military strike on Iran, under an operation reportedly renamed "Sledgehammer", following requests from Gulf allies including Qatar, Saudi Arabia and the United Arab Emirates. Pakistan, Qatar, Saudi Arabia, Turkey and Egypt have over the past several days been engaged in efforts to fine-tune a proposal aimed at narrowing differences between the fighting countries, according to Axios. Two Arab officials and an Israeli

source told Axios that Qatar recently shared a revised draft proposal with the US and Iran. However, another source said there was no independent Qatari proposal and that Doha was instead attempting to reconcile differences in an earlier Pakistani-backed draft. One Arab official said Qatari representatives travelled to Tehran earlier this week to hold discussions with Iranian officials over the updated proposal. "As stated previously, Qatar has been and continues to support the Pakistani-led mediation efforts, we have been consistently advocating for de-escalation for the sake of the region and its people," a Qatari diplomat said. Iran's Foreign Ministry said on Wednesday that negotiations were continuing "based on Iran's 14-point proposal" and added that Pakistan's interior minister was in Tehran to assist the mediation process. It marked the minister's second visit in less than a week. Iran's Foreign Ministry spokesperson said that for the negotiations to move forward, the US would need to stop its "piracy" against Iranian vessels and release frozen Iranian funds, while Israel would have to end its war in Lebanon. As per Axios, all three sources cautioned that it remained uncertain whether Iran would accept the latest draft or substantially alter its current position.
